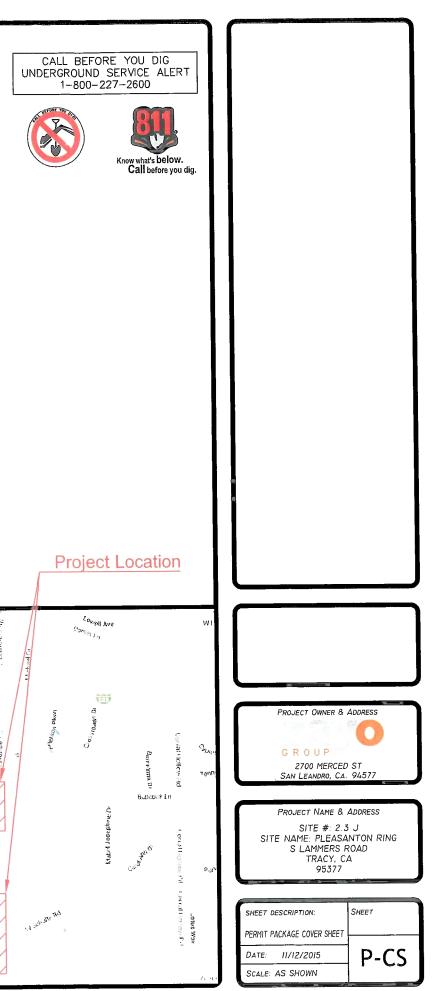

GENERAL NOTES

1. ALL MATERIALS AND WORKMANSHIP SHALL CONFORM TO THE CITY'S STANDARD DETAILS, TECHNICAL SPECIFICATIONS, AND GENERAL REQUIREMENTS.

2. CONTRACTOR SHALL SECURE A ENCROACHMENT PERMIT FROM THE CITY ENGINEERING DEPT. AND PAY APPROPRIATE FEE PRIOR TO COMMENCEMENT OF WORK. ALL WORK WITHIN THE PUBLIC RIGHT OF WAY SHALL BE DONE UNDER AN ENCROACHMENT PERMIT.

3. IT IS THE CONTRACTORS RESPONSIBILITY TO VERIFY THE LOCATION OF ALL EXISTING UTILITIES WITH THE APPROPRIATE UTILITY AGENCIES PRIOR TO THE COMMENCEMENT OF CONSTRUCTION. CONTRACTOR SHALL NOTIFY ALL PUBLIC & PRIVATE UTILITY OWNERS 48 HOURS PRIOR TO COMMENCEMENT OF WORK ADJACENT TO THE UTILITY. CONTACT UNDERGROUND SERVICE ALERT (USA) AT 800-642-2444

4. ALL SIDEWALK, CURB, AND GUTTER SHALL BE REMOVED AND REPLACED TO THE NEAREST SCORE MARK OR AS DIRECTED BY THE ENGINEER. INSTALLATION OF NEW SIDEWALK, CURB & GUTTER AGAINST EXISTING IMPROVEMENTS SHALL REQUIRE A SIDEWALK CONTACT JOINT (DOWELS REOUIRED)

5. UNLESS OTHERWISE DIRECTED BY THE CITY ENGINEER IN THE FIELD: AT EACH LOCATION WHERE NEW CURB/GUTTER IS TO BE INSTALLED ON AN EXISTING STREET (DRIVEWAY INSTALLATION, DRIVEWAY ABANDONMENT, CURB RAMP INSTALLATION, CURB FACE DRAINAGE INSTALLATION, ETC.) PAVEMENT RECONSTRUCTION SHALL BE REQUIRED. AN 18" WIDE BAND OF PAVEMENT SHALL BE REMOVED AND REPLACED ALONG THE ENTIRE LENGTH OF CURB/GUTTER INSTALLATION. REMOVAL DEPTH (SAW CUTS REQUIRED) SHALL BE TO THE BASE MATERIAL ON STREETS WITH A C. OR P. C.C. PAVEMENT FOUR (4) INCHES OR LESS IN THICKNESS. REMOVAL DEPTH SHALL BE TWO INCHES MINIMUM ON STREETS WITH A.C. (GRIND) / P.C.C. (SAW CUT) PAVEMENT THICKNESS GREATER THAN FOUR (4) INCHES. REPLACE WITH A.C. PAVEMENT.

6. BLACK SAND SLURRY SEAL SHALL BE REQUIRED ON ALL NEW STREET PAVEMENT FOR TRENCH WORK, POTHOLES, AND STREET WIDENINGS. SLURRY SEAL SHALL EXTEND 12" BEYOND THE LIMIT OF PAVEMENT RECONSTRUCTION.

7. THE CONTRACTOR SHALL NOTIFY, BY CIRCULAR, ALL BUSINESS ESTABLISHMENTS & RESIDENCES LOCATED IN AREAS AFFECTED BY THE WORK AT LEAST (48) HOURS PRIOR TO START OF CONSTRUCTION. CIRCULAR SHALL BE SUBJECT TO THE APPROVAL OF THE CITY ENGINEER

8. ALL MANHOLES, VALVE BOXES, MONUMENT BOXES, AND OTHER STRUCTURES IN THE PAVEMENT AREA SHALL BE ADJUSTED TO FINISH GRADE BEFORE PAVING FINAL LIFT.

9. GRADE BREAKS ON CURBS AND SIDEWALKS ARE TO BE ROUNDED OFF ON FORM WORK & FINISHED SURFACING.

10. IT IS THE CONTRACTORS RESPONSIBILITY TO REPLACE ALL STREET MONUMENTS OR LOT CORNER PIPES DISTURBED DURING THE PROCESS OF CONSTRUCTION. IF A STREET MONUMENT HAS THE POTENTIAL OF BEING DISTURBED, A CORNER RECORD SHALL BE FILED WITH GOVERNING CITY/COUNTY SURVEYOR (PER SECTION 8773.2 OF THE PUBLIC LAND SURVEYORS ACT) AS REQUIRED BY THE SUBDIVISION MAP ACT TO PRESERVE THE LOCATION OF SAID STREET MONUMENT. CONTRACTOR SHALL, AT HIS/HER EXPENSE, HIRE A CIVIL ENGINEER OR LAND SURVEYOR TO PERFORM THE WORK

11. ALL SURPLUS & UNSUITABLE MATERIAL SHALL BE REMOVED FROM PUBLIC RIGHT OF WAY.

12. CONTRACTOR SHALL PROVIDE ADEQUATE DUST CONTROL & KEEP MUD & DEBRIS OFF THE PUBLIC RIGHT OF WAY AT ALL TIMES.

13. ALL TRENCHES & EXCAVATIONS SHALL BE CONSTRUCTED IN STRICT COMPLIANCE WITH THE APPLICABLE SECTIONS OF CALIF. & FEDERAL O.S.H.A. REQUIREMENTS & OTHER APPLICABLE SAFETY ORDINANCES. CONTRACTOR SHALL BEAR FULL RESPONSIBILITY FOR TRENCH SHORING DESIGN & INSTALLATION.

14. EXISTING UTILITIES SHOWN ARE BASED UPON RECORD INFORMATION & ARE APPROXIMATE IN LOCATION & DEPTH. THE CONTRACTOR SHALL POTHOLE ALL EXISTING UTILITIES THAT MAY BE AFFECTED BY NEW FACILITIES IN THIS CONTRACT, VERIFY ACTUAL LOCATION & DEPTH, & REPORT POTENTIAL CONFLICTS TO THE ENGINEER PRIOR TO EXCAVATING FOR NEW FACILITIES.

15. THE CONTRACTOR SHALL POTHOLE ALL EXISTING UTILITIES THAT MAY BE ALLOW HARMFUL POLLUTANTS TO ENTER THE STORM DRAIN SYSTEM. TO ENSURE COMPLIANCE, THE CONTRACTOR SHALL IMPLEMENT THE APPROPRIATE BEST MANAGEMENT PRACTICE (BMP) AS OUTLINED IN THE BROCHURES ENTITLED "BEST MANAGEMENT PRACTICE FOR THE CONSTRUCTION INDUSTRY" ISSUED BY THE MARIN COUNTY VALLEY NONPOINT SOURCE POLLUTION CONTROL PROGRAM. TO SUIT THE CONSTRUCTION SITE & JOB CONDITION.

16. OVERNIGHT PARKING OF CONSTRUCTION EQUIPMENT IN THE PUBLIC RIGHT OF WAY SHALL NOT BE PERMITTED, EXCEPT AT LOCATION(S) APPROVED BY THE CITY TRAFFIC ENGINEER.

17. UNLESS OTHERWISE NOTED, CLASS 2 A.B. UNDER CURB, GUTTER, & STREET SECTIONS PAVED WITH ASPHALT CONCRETE SHALL BE COMPACTED TO 95% RELATIVE COMPACTION (MINIMUM

18. ALL TRAFFIC CONTROL DEVICES SHALL BE IN PLACE BEFORE WORK IS STARTED DEVICES NO LONGER REQUIRED SHALL BE REMOVED AS SOON AS POSSIBLE

19 PEDESTRIAN TRAFFIC MUST BE MAINTAINED AT ALL TIMES PEDESTRIANS MAY BE RELOCATED ONTO PRIVATE PROPERTY WITH OWNERS PERMISSION ONL'

GENERAL NOTES

20 NO FOUIPMENT OR MATERIALS SHALL BE STORED OR PERMITTED TO STAND UNPROTECTED WHERE TRAFFIC IS MAINTAINED UNLESS IT IS ALLOWED BY THE CITY ENGINEER IN WRITING

21. NO EQUIPMENT OR MATERIALS SHALL BE STORED ON ROAD SURFACE DURING NON-WORKING PERIODS UNLESS IT IS ALLOWED BY CITY ENGINEER IN WRITING

22. NO EQUIPMENT OR MATERIALS SHALL BE STORED ON SIDEWALK AT ANYTIME

23. EXCAVATION MATERIALS SHALL BE STORED AWAY FROM THE PAVED ROADWAY WHENEVER POSSIBLE. ALL SPILLED MATERIAL IS TO BE REMOVED TO AVOID SLIPPERY CONDITIONS

24 EXISTING SIGNS, DELINEATIONS, GUARDRAILS, MARKERS, TREES, SHRUBS, FENCES, WALKS, STEPS, ETC. THAT ARE DISTURBED BY THIS CONSTRUCTION SHALL BE REPLACED OR RESTORED TO THEIR ORIGINAL CONDITION OR TO THE SATISFACTION OF THE ADJACENT PROPERTY OWNERS AND THE GOVERNING CITY/COUNTY AGENCY.

CONSTRUCTION NOTES

1. THE METHOD OF CONSTRUCTION SHALL BE BY HORIZONTAL BORING UNLESS OTHERWISE APPROVED BY THE CITY

2. (1)4" PVC W/(3) 1.25" INDT. SHALL BE INSTALLED ON ALL OPEN TRENCHING UNLESS SHOWN OTHERWISE

3. EXISTING UTILITIES ARE SHOWN IN APPROXIMATE LOCATIONS ONLY. NOT ALL EXISTING UTILITIES ARE SHOWN ON THIS PLAN. THE CONTRACTOR SHALL FIELD VERIFY DEPTH AND LOCATION OF ALL UTILITIES BY EXPOSING UTILITY CROSSINGS PRIOR TO DIRECTIONAL BORING. THE CONTRACTOR SHALL USE HAND TOOLS AND EXTREME CARE WHEN WORKING IN CLOSE PROXIMITY TO EXISTING UTILITIES.

4. FOR OPEN CUT TRENCHING THE FOLLOWING MINIMUM CLEARANCES SHALL APPLY A 12" VERTICAL CLEARANCE AT ALL CROSSINGS SHALL BE MAINTAINED BETWEEN PROPOSED CONDUITS AND OTHER EXISTING UTILITIES. A 8 MINIMUM HORIZONTAL CLEARANCE SHALL BE MAINTAINED BETWEEN PROPOSED CONDUITS AND EXISTING SANITARY SEWER AND STORM DRAIN MAINS THAT RUN PARALLEL, UNLESS APPROVED BY THE CITY. THE CONTRACTOR SHALL MAINTAIN A MINIMUM OF 5' HORIZONTAL CLEARANCE FOR ALL OTHER UTILITIES UNLESS OTHERWISE APPROVED BY THE CITY. EXCEPT WHEN AT THE SAME ELEVATION AS WATER MAINS, 8' HORIZONTAL CLEARANCE SHALL BE MAINTAINED UNLESS OTHEWISE APPROVED BY THE CITY. CLEARANCES ALSO APPLY TO FIRE HYDRANTS.

5. THE FOLLOWING MINIMUM CLEARANCES (FROM REAMED PERIMETER OF THE BORE HOLE TO THE OUTER PERIMETER OF THE UTILITY) SHALL BE USED AS A GUIDELINE. THE GEOTECHNICAL REPORT CONCLUSIONS & RECOMMENDATIONS OR THE CITY'S DETERMINATION SHALL BE FOLLOWED, IF MORE RESTRICTIVE

(A) LOCATE HDD 8 FT. CLEAR (HORIZONTALLY) FROM THE EXISTING STORM DRAIN & SANITARY SEWER (A) LOGATE TO BE THE CARE THE SAME ELEVATION AS WATER MAINS, 8 FT. HORIZONTAL CLEARANCE SHALL BE MAINTAINED. MINIMUM OF 5 FT. HORIZONTAL CLEARANCE SHALL BE MAINTAINED FROM FIRE HYDRANTS, ELECTRICAL, GAS, ETC.). CROSSING SHALL BE AT 90-DEGREE.

(B) USE THE FOLLOWING CHART FOR MINIMUM DEPTH OF COVER (IN THE PAVEMENT & SIDEWALK AREAS) & MINIMUM CLEARANCE WHEN CROSSING UTILITIES (STORM DRAIN, SANITARY SEWER, WATER, ELECTRICAL CONDUITS, BOXES, & VAULTS.

6. AT THE END OF EACH DAY, CONDUIT CAPS SHALL BE PLACED ON ALL VACANT DUCTS. DUCT IN BUILDING ENTRANCES, NEW OR EXISTING SHALL BE SEALED PRIOR AND AFTER PLACEMENT OF FIBER OPTIC CABLE IS COMPLETED, INCLUDING DUCTS ON WALL WHERE CORING IS REQUIRED.

7. THE REMOVAL, STORAGE, AND REPLACEMENT OF ALL SHRUBBERY SHALL BE THE RESPONSIBILITY OF CONTRACTOR. ALL LANDSCAPING SHALL BE RESTORED TO ORIGINAL OR BETTER CONDITIONS

8. TRAFFIC SIGNAL CIRCUITS AND INTERCONNECT CONDUITS MAY NOT BE SHOWN. CONTRACTOR SHALL LOCATE ALL TRAFFIC SIGNAL CIRCUITS AND INTERCONNECT CONDUITS PRIOR TO ANY TRENCHING OR BORING. PROVIDE 5' SEPARATION BETWEEN NEW CONDUITS AND ALL TRAFFIC SIGNAL AND INTERCONNECT CONDUITS AND 5' FROM ALL TRAFFIC SIGNAL CONTROLLERS AND PULL BOXES. ALL TRAFFIC SIGNAL AND INTERCONNECT CONDUITS SHALL BE MAINTAINED AND PROTECTED. LOOPS OR CONDUITS DAMAGED SHALL BE REPLACED BY THE CONTRACTOR TO CITY SPECIFICATIONS. NOTIFY CITY INSPECTOR IMMEDIATELY AND TRAFFIC DEPARTMENT 48 HOURS PRIOR TO ANY WORK IN THESE AREAS.

9. APPROXIMATE LOCATIONS OF SPLICE BOXES ARE SHOWN ON THE PLANS. EXACT FINAL LOCATION OF SPLICE BOXES SHALL BE DETERMINED IN THE FIELD WITH CITY APPROVAL AFTER ALL EXISTING UTILITIES IN THE AREA OF WORK HAVE BEEN

10. TOPS OF SPLICE BOXES SHALL BE SET FOR FUTURE SIDEWALK INSTALLATION IN SPECIFIED LOCATIONS ALL SPLICE BOXES SHALL BE PLACED WITH PEDESTRIAN TRAFFIC SAFETY IN MIND UNTIL ALL WORK IS COMPLETE

11. THE CITY WATER DEPARTMENT SHALL BE NOTIFIED A MINIMUM OF 24 HOURS PRIOR TO POT HOLING ANY CITY WATER OR RECLAIMED WATER MAINS OR SERVICES.

CITY ARBORIST NOTES:

1. NO TRENCHING SHALL BE DONE WITHIN THE DRIPLINE OF EXISTING TREES WITHOUT THE APPROVAL OF THE CITY ARBORIST. OPEN TRENCHING IN THE ROOT ZONE OF A PUBLIC TREE IS PROHIBITED EXCEPT IN CASES WHERE THE TRENCHING FALLS OUTSIDE THE TREE INVOLVED. EXCEPTIONS WILL BE ALLOWED IF, IN THE OPINION OF THE CITY ARBORIST, THE IMPACT OF TRENCHING UPON THE TREE WILL BE NEGLIGIBLE.

2. NO CUTTING OF ANY PART OF CITY TREES, INCLUDING ROOTS SHALL BE DONE WITHOUT SECURING APPROVAL AND DIRECT SUPERVISION FROM THE CITY ARBORIST.

3. NO CUTTING OF ANY PART OF PRIVATE TREES, INCLUDING ROOTS, SHALL BE DONE WITHOUT SECURING SUPERVISION OF A CERTIFIED ARBORIST (CERTIFICATION OF INTERNATIONAL SOCIETY OF ABORICULTURE).

4. BORE OUTSIDE THE DRIPLINE OF ALL TREES TO PREVENT ROOT DAMAGE. NO BORE PITS ARE ALLOWED WITHIN THE DRIPLINE OF ANY EXISTING TREE

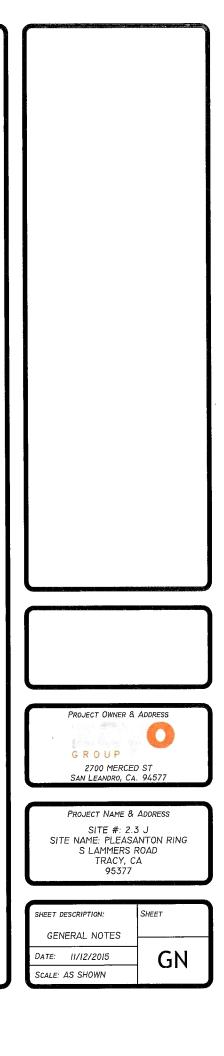
5. TUNNELING: ALL PUBLIC TREES IN EXCESS OF 5" DBH, WHERE THERE IS INSUFFICIENT SPACE TO BYPASS THE DRIPLINE BY TRENCHING, MUST BE TUNNELED THE BEGINNING/ ENDING DISTANCE OF THE TUNNEL FROM THE FACE OF THE TREE IN ANY DIRECTION IS DETERMINED BY THE DIAMETER OF THE TREE AS SPECIFIED BY THE ACCOMPANYING TABLE:

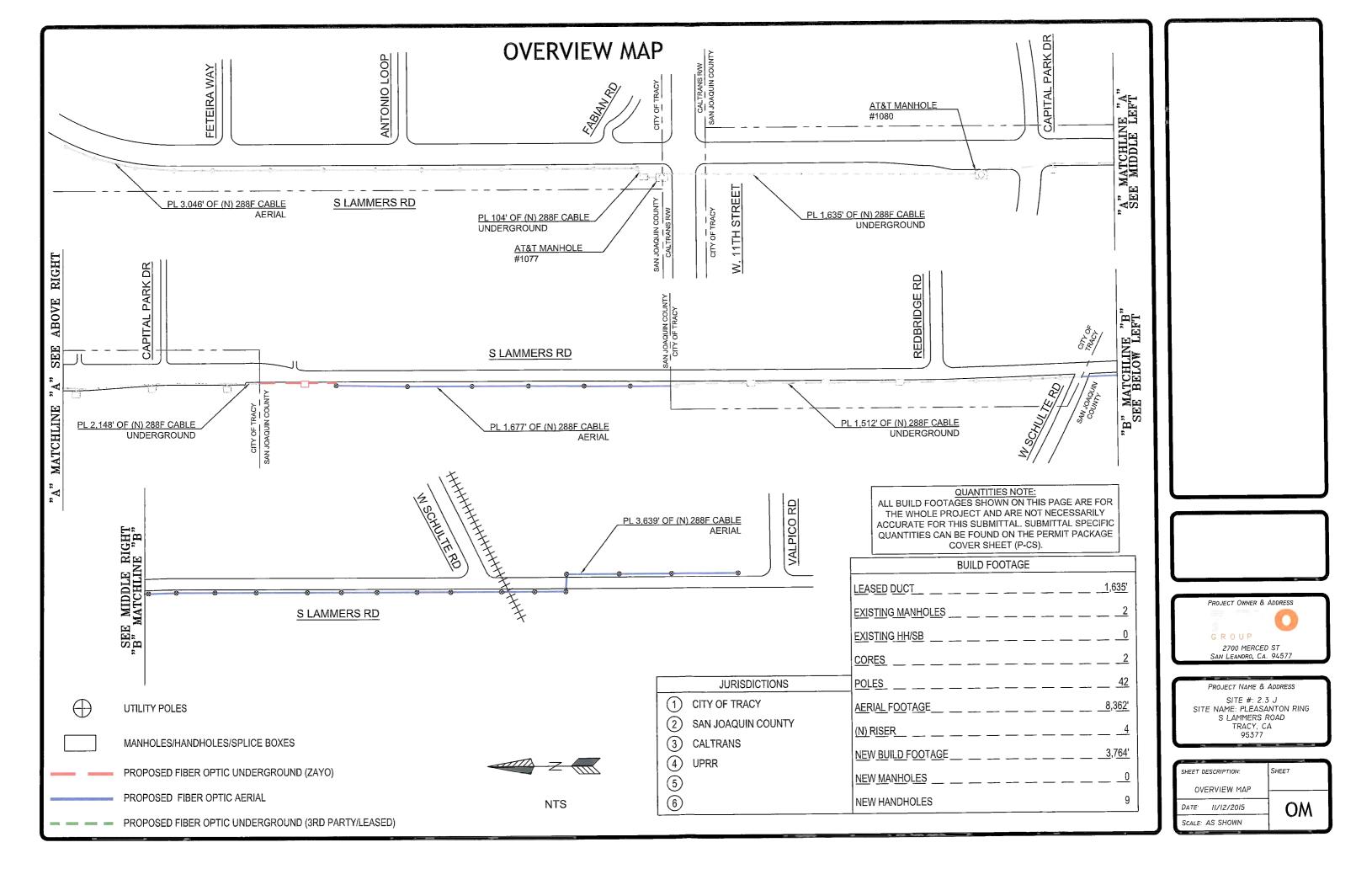

- 1. This permit is issued under and subject to all laws and ordinances of agencies governing the encroachment herein permitted. See the following references:

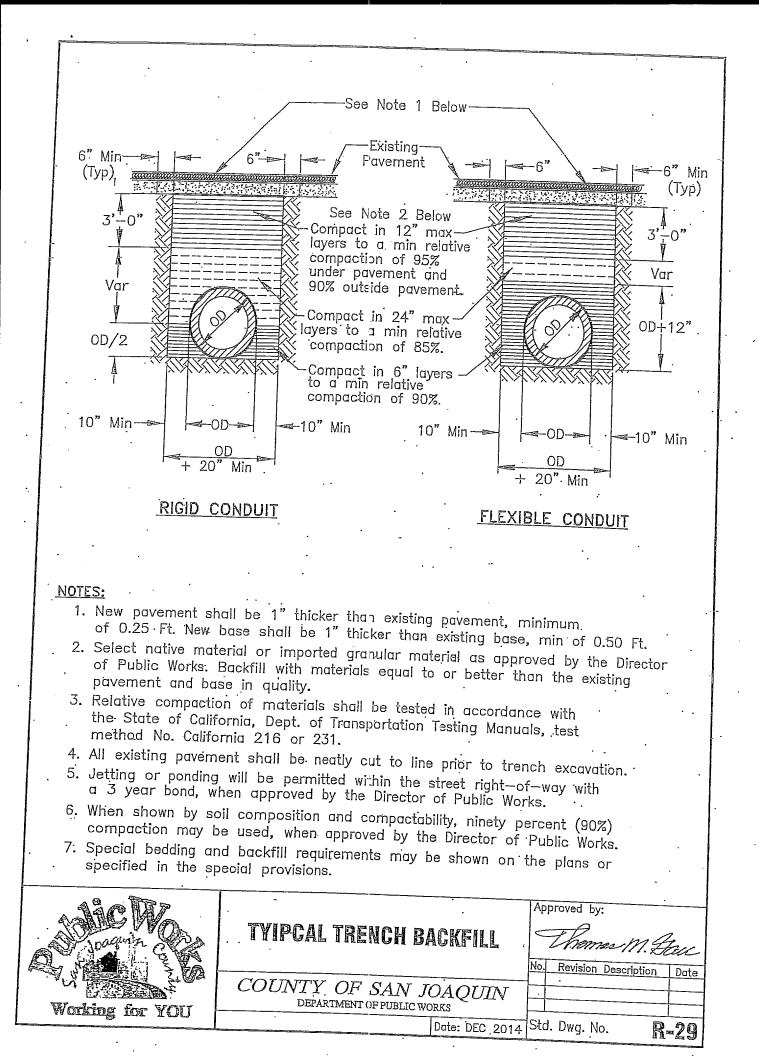
SAN JOAQUIN COUNTY ORDINANCES NUMBERED: 324, 441, 648, 662, 672, 695, 700, 860, 892, 3359, and 3675.

- 2. It is understood and agreed by the Permittee that the performance of any work under this permit shall constitute an acceptance of all the provisions contained herein and failure on the Permittee's part to comply with any provision will be cause for revocation of this permit. Except as otherwise provided for public agencies and franchise holders, this permit is revocable on five days notice.
- 3. All work shall be done subject to the supervision of and the satisfaction of the grantor. The Permittee shall at all times during the progress of the work keep the County Highway in as neat and clean condition as is possible and upon completion of the work authorized herein, shall leave the County Highway in a thoroughly neat, clean and usable condition.
- 4. The Permittee also agrees by the acceptance of this permit to properly maintain any encroachment structure placed by the Permittee on any part of the County Highway and to immediately repair any damage to any portion of the highway, which occurs as a result of the maintenance of the said encroachment structure, until such time as the Permittee may be relieved of the responsibility for such maintenance by the County of San Joaquin.
- 5. The Permittee also agrees by the acceptance of this permit to make, at its own expense, such repairs as may be deemed necessary by the County Department of Public Works.
- 6. It is further agreed by the Permittee that whenever construction, reconstruction or maintenance work upon the highway is necessary, the installation provided for herein shall, upon request of the County Department of Public Works, be immediately moved or removed by and at the sole expense of the Permittee.

GENERAL PROVISIONS

GOVERNING INSTALLATION OF SUBSURFACE STRUCTURES AND PIPELINES WITHIN COUNTY ROAD-RIGHTS-OF-WAY

PUBLIC CONVENIENCE AND SAFETY:

- A. Before obstructing any private driveway entrance or County road traveled way with a trench, spoil bank, equipment or other barrier permitted for any prolonged period of time, the Permittee shall notify the known users of the respective thoroughfare(s) involved, and shall provide access for vehicular and pedestrian traffic to and from the road.
 - Unless otherwise permitted, all work shall be conducted in such a manner that no less than one lane of the existing County road traveled way will 1. be maintained open to public traffic during working hours in a smooth and safe riding condition(s). Two lanes shall be open after working hours.
 - In cases where road closure is permitted, the permission to close the road will be granted under the condition that the Permittee notify the 2. following persons and/or agencies of the time, the period of closure, and the detour route at least twenty-four (24) hours prior to said road closure.
 - The County of San Joaquin Public Works Department a _d_ The local fire district
 - The County of San Joaquin Sheriff's Office Ъ. The local school district e.
 - c. The local postal service f. The local residents involved
- Should hazardous conditions relative to the installation operations warrant flagmen, as many capable flagmen as may be necessary shall be provided by the B. Permittee and stationed in advance of work to warn and direct trafic.
- Lights, signs and barricades shall be furnished, erected and maintained by the Permittee for the adequate warning and convenience of the public, with C particular attention to be taken in this regard after dark.
- D. Any excess dirt and/or debris which might be a hazard to either auromobile or pedestrian traffic, uncontrollable by lights, signs and barricades, shall be removed from the jobsite daily.

STRUCTURES:

- A. Walls of structures shall be such quality and strength that they will resist all pressures and will not crack or be deformed in such a way as to create a hazard or maintenance problem at any time. Therefore, the minimum structural requirements for concrete pipe placed under county road rights-of-way shall conform to the following American Association of State Highway and transportation Officials (AASHTO) designations.
 - 1.
 - For concrete pipe up to and including thirty-three inches (33") inside diameter, extra strength concrete conforming to AASHTO Designation M 170M. 2.
 - For concrete pipe thirty-six inches (36") inside diameter and larger, reinforced concrete pipe conforming to AASHTO Designation M 170M Class Ш. 3.
 - Plastic pipe conforming to AASHTO Designation M294.
- B. All concrete pipe joints with County road rights-of-way shall be sealed against leakage and/or infiltration with rubber gasket in conformance with Section 65-1:06 of the California Standard Specifications, or with other methods as may be permitted under the Special Provisions.
- Cast-in-place concrete pipe, vitrified clay pipe, spiral welded steel pipe, or corrugated aluminum alloy pipe shall not be installed within the County road C. rights-of-way unless specifically so stated in the Special Provisions, and only under the conditions as provided.
- All structures to be buried within the County rights-of-way shall be set at such elevations as to allow minimum coverage of thirty inches (30") to the D. centerline of the roadways and twelve inches (12") at the bottoms of borrow ditches each side of the roadways. The depths of structures shall be established below a flat plane extending across the rights-of-way, no part of which shall extend above the elevations stated above; manhoies, lampholes, valves, etc. not
- included. Future surface elevations shall be anticipated as nearly as possible and structure elevations shall be established for future adjustments accordingly. The County hereby reserves the right to specify in the Special Provisions the gage and surface treatment of any galvanized corrugated metal pipe that is to be E. installed.
- All longitudinal utility facilities are to be established (and dimensioned on sketches) from surveyed centerline of road right-of-way, not from right-of-way F. (border) lines.

REPAIRS OF THE COUNTY RIGHT-OF-WAY:

- All excavations shall be backfilled and compacted immediately after work therein has been completed. A.
- Trenched shall not be left open farther than 300 feet in advance of pipe laying operations, or 200 feet to the rear thereof, unless otherwise permitted by the B. Engineer.
- C. Unless otherwise permitted under the Special Provisions, backfill shall be placed and mechanically compacted in such a manner that the relative compaction throughout the entire fill within the County road right-of-way shall conform to the percentages of compaction as shown on the Trench detail.
- Backfill material shall be placed in horizontal uniform layers not to exceed in thickness, before compaction, 0.67 foot in the bedding region, one-foot where D. 90% compaction is required, and two-feet where 80% compaction is required.
- E. No portion of the excavation(s) shall be compacted by ponding or jetting unless a maintenance bond is provided.
- Gravel backfill material shall be utilized only where specifically so stated on the face of the permit. It shall be compacted by means of a high-frequency F. internal vibrator, the compactor to be a size and type approved by the Engineer. Points of compaction shall not be greater than 18" centers and to the full depth of the lift.
- G. All pavements, curbs, gutters, sidewalks, borrow ditches, pipes, head walls, road signs, trees, shrubbery, and/or other permanent road facilities impaired by or as a result of construction operations at the construction site(s) occupied by materials and/or equipment, shall be restored immediately upon backfilling of the excavation to the original grades and cross sections, and to a condition as good as, or better than existing prior to construction.
- All surfacing materials of roadways and driveway approaches cut or damaged by or as a result of construction operations, shall be replaced within ONE H. WEEK following the backfilling of excavation, weather permitting, with compacted layers of surfacing materials at least as thick as the existing, and no less than two inches (2") of asphalt concrete over six inches (6") of aggregate base, both as specified below.
 - Asphalt Concrete: Combined mineral aggregate shall conform to the quality and gradation requirements for Type "B" one-half inch(1/2) ·£.~ maximum aggregate, coarse or medium gradation as specified in Section 39 of the California Standard Specifications. The bituminous binder to be mixed with mineral aggregate shall be paving asphalt having (Grade PG 64-10), unless otherwise directed by the Engineer. Placement of asphalt concrete surfacing shall conform to the applicable provisions of Section 39 of the California Standard Specifications.
 - Aggregate Base: Combined mineral aggregates shall conform to the quality and the grading for three-quarter inch (3/4") maximum size 2. aggregate Class 2 Aggregate Base specified in Section 26 of the California Standard Specifications.
- Before acceptance of repairs to the County road rights-of-way, all unsightly and detrimental dirt, dust and/or debris shall be removed and the construction L areas left in a neat and presentable condition(s).
 - If necessary, County road traveled way and driveway pavements shall be washed with water to remove dirt and dust. 1. 2
- Driveway approaches and field entrance pavements damaged by equipment or spoil banks shall be repaired as directed by the Engineer. Upon request by the County, any settlement, sagging of surface, or cracking of pavement shall be repaired immediately by and at the sole expense of the J. Permittee for a period of one year following acceptance of the work.

SPECIAL PROVISIONS

Winter Weather Utility Work

- 1. <u>SUPERVISION:</u> The utility company (permittee) shall furnish full-time supervision of all work to insure compliance with the permit provision.
- 2. <u>START OF WORK:</u> No work within the County right-of-way shall be started until the utility company representative has made an evaluation of weather conditions and has determined the work can be accomplished under the provisions of the permit.
- 3. <u>CLEAN PAVEMENT:</u> Dirt and mud shall not be deposited on the pavement outside the area of work, and if inadvertently tracked onto the road travel way shall be removed immediately.
- 4. **<u>DAILY RESTORATION:</u>** Private driveways and road intersections shall be restored daily.

5. <u>WEATHER-TIGHT CONDITIONS:</u> All trenches shall be filled and compacted, ditches and other drainage facilities regarded and opened, and the entire work area restored to weather-tight condition prior to any rain.
