Please contact the staff person indicated below to inform them of the status of the complaint allegations (valid or not valid) and any corrective actions taken, or to be taken, if applicable.

Please be advised that failure to correct substandard housing violations may result in further enforcement action by the EHD. All enforcement action costs are recovered as specified below.

**AUTHORITY:** California Health and Safety Code, Section 17910 et. seq.; Uniform Code for the Abatement of Dangerous Buildings; San Joaquin County Ordinance Code, Title 8, Division 5.

**RECOVERY OF ENFORCEMENT COSTS:** Pursuant to San Joaquin County Ordinance Code Section 8-5400(a), "The County shall be reimbursed for all time, services and materials needed to abate a violation of this division." The current approved EHD hourly rate used to compute the cost of time spent to investigate, document and abate a violation is \$152.00 per hour.

**PERMITS:** Where structural, electrical, plumbing, or mechanical violations exist, appropriate permits must be obtained from the San Joaquin County Building Division (SJCBD) prior to rehabilitation. If the structure(s) are to be demolished, a demolition permit must be obtained from the SJCBD. Permits for Mobile Homes must be obtained from the California Department of Housing and Community Development prior to rehabilitation.






